1.0 Introduction

The Department of Toxic Substances Control (DTSC) supervised the mailing of a community survey to 96,448 residents living within a five-mile radius of the Santa Susana Field Laboratory (SSFL) located in southeastern Ventura County (see map below). The survey was mailed to the general public in two stages, the first mailing was sent out in June 2001, and the second and final mailing was undertaken in January 2002.

The survey was undertaken in order to document the public's comments and concerns relating to DTSC's cleanup activities taking place at the SSFL. The survey results will be used to develop a revised DTSC Public Participation Plan and community outreach strategy for 2003.

- A total of 3,379 (3.5 %) surveys were return-mailed by the public living within 32 geographical locations (see page 83 for location of returned survey responses).

There are four main sections, and sixteen subsections to this report. Where relevant, each section begins with the original survey question followed by the public's unabridged comment.

- Unabridged public comment has been compiled under specific concerns, and then sorted alphabetically by mailing address.
- Name and mailing address information has been omitted in order to protect the identity of survey respondents.

Copies of the community survey results are available at local information repositories as listed in Appendix B (page 85).

Figure 1: Site Map of the Santa Susana Field Laboratory (SSFL)

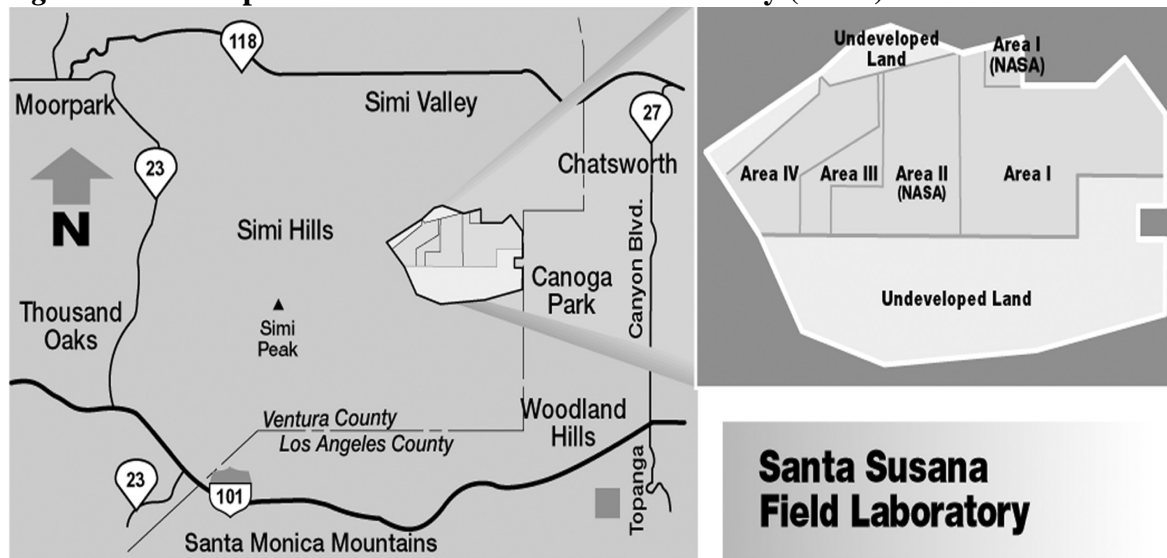

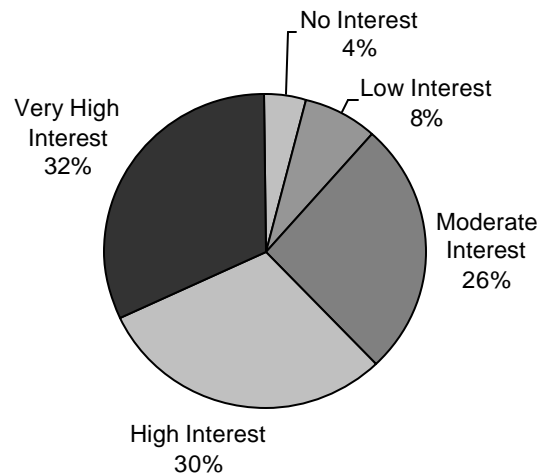

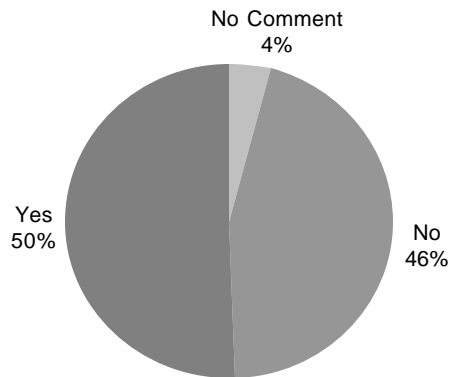

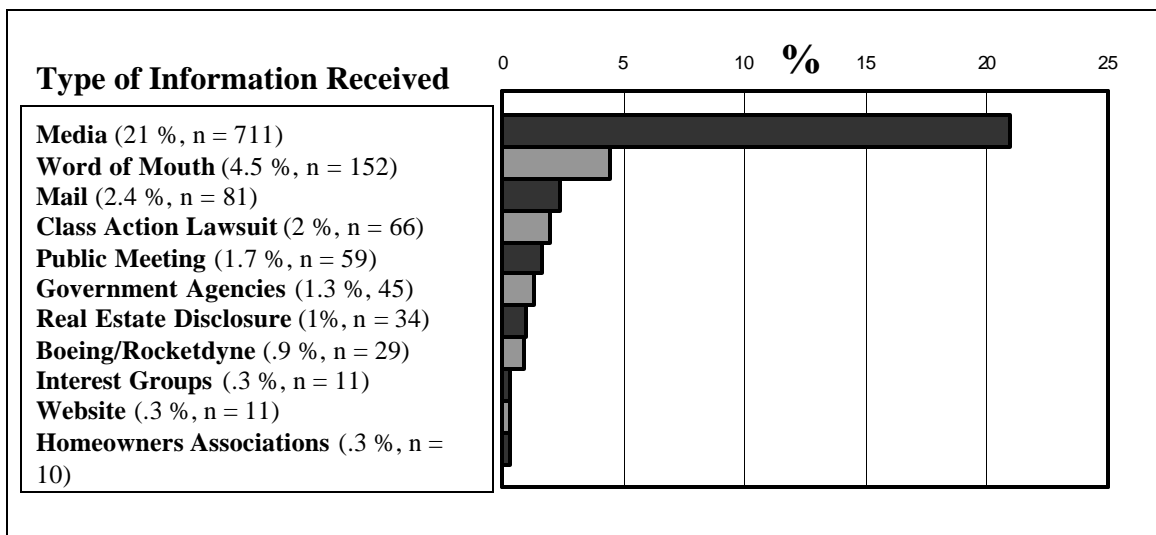
Figure 3: Survey Respondents Knowledge of Facility or DTSC's Clean-Up Activities

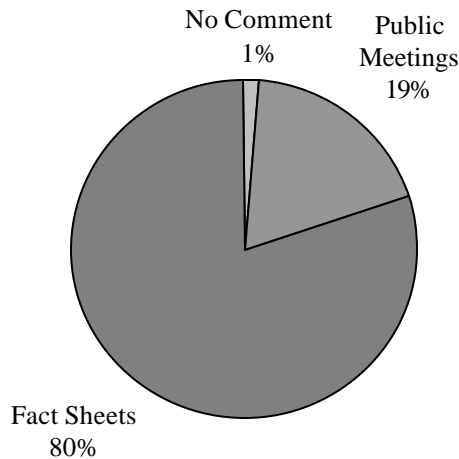
Figure 4: How Survey Respondents Receive Information

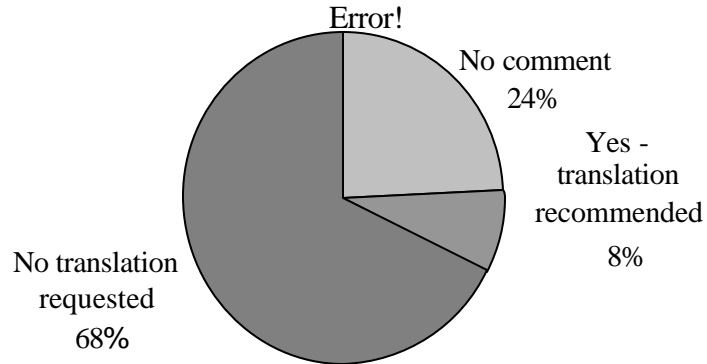

7.1. Public comments concerning the distribution of information

Number of Public Responses 283 (8 %)

Note: All public comments are unabridged direct quotes.

Public response from Bell Canyon:

1. *Need honest appraisal from a community based and hired pollution expert – paid by SSFL. [Bell Canyon]*
2. *I grew up in a town that was a Superfund cleanup site. If there is a need for clean up, then do it. I am not at all interested in the NOISE of public meetings, negative press and litigation that surrounds and ultimately undermines the community more so than the actual hazardous waste site itself. The community is hurt more by negative coverage than the impact of the environmental problem. Clean up/move on is my advice to everyone. I have strong opinions, why is it counterproductive to beat the drum on this issue ad nuseum. [Bell Canyon]*

Public comments concerning the distribution of information continued:

Public response from Burbank:

3. *I am very involved in environmental causes, and would like to be informed regarding the above matter. [Burbank]*

Public response from Calabasas:

4. *Let's face it - public health risk for this site is miniscule. I think there are enough people on this bandwagon already. A media campaign does not accomplish the cleanup. In fact, it would only serve to lengthen the whole job. [Calabasas]*

Public response from Canoga Park:

5. *Quarterly mailed updates would be appreciated. [Canoga Park]*
6. *So what is happening? – Details please!! [Canoga Park]*
7. *I feel it is very important that we be kept informed completely regarding any situations of potential danger – past, present, future. [Canoga Park]*
8. *The summit management does not disclose the contamination/clean up of the Rocketdyne Lab as required by law! A disclosure should be separate and should be initiated by all new residents! [Canoga Park]*
9. *Mail fact sheets to people and have an Email newsletter. [Canoga Park]*
10. *This is the first correspondence we received whatsoever in reference to our local exposure. [Canoga Park]*
11. *Establish a Website on the Internet. [Canoga Park]*
12. *I would like to receive information about health issues involved with the Rocketdyne Laboratory. [Canoga Park]*
13. *I've been a tenant in Mt. View Mobile Home estate for 23 years. Was never informed about reactors, toxic waste etc until years latter. I request that anyone moving into the area be informed of existing condition. [Woolsey Canyon, Canoga Park]*
14. *I grew up in Chatsworth Lake area and always heard rumors about cancer and Rocketdyne. [Canoga Park]*
15. *I just want to make sure we are kept informed of all the new developments related to this situation in my community [Canoga Park]*
16. *I had no understanding of this Lab. and I am interested in its activities to ensure that they do not pose any danger to my community. [Canoga Park]*
17. *Yes, please send us more information we need more information to be better educated on the situation with regards to this site. [Canoga Park]*
18. *Post the information on a web site. [Canoga Park]*
19. *Problem is that I don't really understand the environmental threat the current condition of the site poses. I have lived at the bottom of the hill (near Roscoe & Valley Circle for over 35 years and don't like the fact that I had a nuclear reactor in my backyard for many years. Apparently, rocket testing has continued to what threat to the community I don't know. [Canoga Park]*

Public comments concerning the distribution of information continued:

20. *The public concern is silly, fueled by a few people who know a few buzzwords, and of course, attorneys. [Canoga Park]*
21. *There is very little information contained in this mail out, I do not feel informed enough to comment on the situation, other then I would like a fact sheet or information regarding cleanup activities at the SSFL. NOTE – I am relatively new to the area (June 01) and perhaps missed previous mailings. [Canoga Park]*
22. *Would be interested in receiving information in the mail, including complete history of situation, as well as current status. [Canoga Park]*
23. *I would suggest some type of use of the local media (TV, newspapers, and radio) to disseminate information on your environmental hazard research. A phone number could then be provided for those (who would probably not be large in number) having additional questions or concerns. This approach would probably be more cost effective than holding meetings or seminars for each individual group or geographical area. [Canoga Park]*
24. *This is the first time that I have heard of the existence of SSFL, or that DTSC is investigating. [Canoga Park]*

Public response from Chatsworth:

25. *Please send me more information. I live in Chatsworth, so I'm very interested. [Chatsworth]*
26. *I have lived in Chatsworth for 18 years and I want to know all I can. [Chatsworth]*
27. *We would like to be kept informed. [Chatsworth]*
28. *Please mail me pertinent information regarding cleanup and toxicity of soils around our location [Chatsworth]*
29. *My low level of concern regarding this facility is probably due to my lack of awareness of the facts and information. I will visit one of the repositories soon. [Chatsworth]*
30. *The fact sheets provide me with the information I need and a phone number to direct questions. The community meetings I attended were a complete waste of my time. Too much arguing from uneducated people with little or no information provided. I am confident Rocketdyne has not contaminated us! Based on my own research. [Chatsworth]*
31. *Plain language and showing genuine concern for the health of local residents is most important. [Chatsworth]*
32. *Why were we included in this mailing? What might our concerns be? Is our location close enough to be adversely affected? [Chatsworth]*
33. *I would like more information, I recently moved to this area one year ago. [Chatsworth]*
34. *Our association had a speaker concerning this matter and a visit by bus? Would be good to have an update discussion. [Chatsworth]*
35. *Feels like the problem has been greatly exaggerated. I do not wish to receive any further information. [Chatsworth]*

Public comments concerning the distribution of information continued:

36. *After the “Belmont” mess any and all investigations are a godsend. I thank you for your persistence in this. All your doing safeguards everyone from future harm regarding the use of the land [Chatsworth].*
37. *Please send on-going information regarding site cleanup progress. [Chatsworth]*
38. *We’re quite concerned about what is being done to correct this situation and the public’s lack of awareness regarding it. Whatever happened to Chatsworth Lake and our groundwater? [Chatsworth]*
39. *We as a community would like to tour the facility to get a first hand look at the problems, and be more informed rather than a load of cover-ups and lies. Thank you so much for your agency getting involved. [Chatsworth]*
40. *I would be interested in any available fact sheets showing the geographical distance at which toxic hazards at SSFL can be expected to impact residents. I would like to be on your mailing list. [Chatsworth]*
41. *I would like to know more about SSFL, and to know if it has affected my family or not [Chatsworth].*
42. *If you have speakers that you provide to educate people on your work, please contact me. We are the Chatsworth Neighborhood Watch, and have monthly meetings where people are kept informed on local matters. [Chatsworth]*
43. *The only information I have received on the SSFL cleanup is from the newspaper. It is not convenient to go to a location to get information, can't information be sent to people in the area, by mail or E-mail. [Chatsworth]*
44. *I would appreciate a copy of this sheet – front and back for information. It would have been nice to have backside on separate sheet so we could keep it for our information. [Chatsworth]*
45. *I had no knowledge of these activities, please keep me informed. [Chatsworth]*
46. *This is the first knowledge I have of this facility, and I am interested in knowing more about it. [Chatsworth]*
47. *Please contact me on any information you may come across. [Chatsworth]*
48. *Please keep us posted. [Chatsworth]*
49. *My kid grows up here, I would like to know what is happening in our neighborhood, and that someone cares about us living here. [Chatsworth]*
50. *I have just become aware of the activities of the California Environmental Protection Agency in the environmental cleanup, and would very much like information regarding this current situation. [Chatsworth]*
51. *We are not that interested on what is going on but would like more information on the situation. [Chatsworth]*
52. *Just keep the public informed as to what is being done to cleanup the facility, and what health hazards may occur. [Chatsworth]*
53. *Provide lots of photos, maps, easy diagrams to catch the eye. [Chatsworth]*
54. *This is the first time I have heard of any of this. What is it all about? I would like more information. [Chatsworth]*
55. *Would like to see details of contamination. [Chatsworth]*

Public comments concerning the distribution of information continued:

Public response from Granada Hills:

Public comments concerning the distribution of information continued:

276. *The more information provided, the less people worry about the situation. Send out information through news media to keep all up to date on all actions and reviews. [no address given]*
277. *In the wake of years of abuse by corporate and industry as a whole, the toxic issues are very scary and people are only now beginning to realize the possible effects on the population. Through the population as a whole is very apathetic, I believe that ANY advocacy on our part is a huge step in the right direction! It's not about – "What can I get away with for my gain," it NEEDS to be taken care of or we ALL lose out. [no address given]*
278. *I am new to this community and was not aware of this matter! [no address given]*
279. *Please give this matter clear attention. [no address given]*
280. *Please take good care of us. [no address given]*
281. *Remember that information in laymen's terms is very important. Sending out timely mailings is also important. [no address given]*
282. *I would like to see public information given out by radio and TV. (no address given)*
283. *I'm a Sierra Club member – they would publish something for you in their newspaper, the monthly "Southern Sierra." [no address given]*

7.2. Public comment relating to health

Note: All public comments are unabridged direct quotes.

Public response from Bell Canyon:

1. *Have lived 24 years within walking distance of the facility. During that period, I have developed prostate cancer. One horse developed severe melanoma, and one dog put down because of cancerous melanoma. [Bell Canyon]*
2. *I am convinced that the SSFL radiation work has had no effects on the surrounding communities. [Bell Canyon]*

Public response from Canoga Park:

3. *My friend who died of cancer talked about the current problems with groundwater contamination. He fought a fire many years ago without any protective gear. [Canoga Park]*
4. *The family I stayed with lost 2 horses, 2 dogs, and 1 cat – all to cancer. I personally lost my cat to cancer and I'm currently fighting breast cancer. It is my belief that soil and brush are contaminated. [Canoga Park]*
5. *I am an asthmatic and have had many problems through the years that might have been caused by living in the Woolsey Canyon. [Canoga park]*

Public comment relating to health continued:

6. *My next door friend and my neighbor across the street both died from cancer. I am currently being treated for breast cancer. What do you think???? [Bobbyboyar Avenue, Canoga Park]*
7. *I met a person inflicted with face cancer. He had worked at the plant & stated he believed his cancer was contracted there. I also know of three other cases of cancer in the past 10 yrs in this area. [Woolsey Canyon, Canoga Park]*
8. *I know a family who lived in the canyon near this facility. The father has lymphatic and lung cancer, and the son has bladder cancer. My next door neighbor's husband died of brain cancer. There is definitely a problem stemming from that facility. You should provide the best water filters to every family. [Canoga Park]*
9. *Am I now afflicted with an autoimmune disease because of this! [Canoga Park]*
10. *After living under Rocketdyne hill and my husband worked there, he died at home of cancer. Me, and many neighbors are dying of cancer and leukemia. I'm concerned and need help. [Canoga Park]*
11. *I have a very high heavy metal content in my body. I am beginning to experience hair loss and loss of memory...I would like to see long term studies on the health of the local populace. [Canoga Park]*
12. *My family has lived in San Fernando Valley for decades and all my family members died of cancer. [Canoga Park]*
13. *We have lived in the same home for 28 years. Our family has been suffering frequently for many years with severe headaches, diarrhea, and other ailments. We have strongly suspected the "SSFL" and the other Rockwell facility (De Soto Ave., at Nordhoff). We have heard that the De Soto facility uses and handles nuclear or radioactive materials at that location. We have a great fear that one or both of the facilities has contaminated the water and air in the area. [Community Street, Canoga Park]*
14. *I feel a general survey of former employees' health is needed. For example, I have had major health surgery three times, starting at age 44. If a large number of former employees had similar histories that should be VERY significant. But how do you know if you don't ask? I have never been asked any questions by any agency. (PS. I also have asthma and mild COPD) [Kentland Ave, Canoga Park]*
15. *My husband developed asthma when he was in his late forties, and I am a cancer survivor. I have always wondered if there is any connection. [Canoga Park]*
16. *I have a friend who was raised in Woodland Hills and she is very concerned that she, her 5 siblings and her mom and dad may have been exposed to potential carcinogens. Her mother is now recovering from cancer. [Canoga Park]*
17. *I would like to see more info on cancer clusters in the community. [Canoga Park]*
18. *I am concerned over increased cancer cases. [Canoga Park]*
19. *I am interested in how many cases of cancer victims that have occurred living in this area. Say, like in the years that Rocketdyne has been located up here? How many cases of birth defects have occurred to residents living near Rocketdyne? Why did this investigation begin? [Canoga Park]*
20. *So many people living in the area have gotten cancer – I cannot believe there isn't a causative link to the toxic site. [Canoga Park]*

Public comment relating to health continued:

21. *I would be interested in a cancer research company doing a study on cancer rates due to being subjected to that lab for 40 years!? The Santa Susana winds kick up all kinds of pollution from that place and deposit it on valley homes!! [Canoga Park]*
22. *Certain individuals have pancreatic cancer, a cancer that may be attributed or contributed to by contaminates at SSFL? Are there other target organs affected by or suspected in the release of toxins from SSFL? [Canoga Park]*
23. *I used to work for Rocketdyne in Chatsworth at time cleanup was going on. I believe I was subjected to toxic contamination between 1995 and 1998. [Canoga Park]*
24. *I have certain physical and neurological problems, which I can relate directly to my time and work functions on the hill. [Canoga Park]*
25. *We've lived within this area over 38 years. We'd like to know what we may have contracted healthwise? [Canoga Park]*
26. *I am very concerned with the risk of disease related to the contamination at the SSFL. I support any action that can be taken to cleanup this hazard. The company doing the testing, or the government agencies involved, or whoever funded the testing should be held accountable and pay for the disposal of the contaminated materials. [Canoga Park]*
27. *I have been concerned if our water had any chemicals from the SSFL, or if some fallout came by wind and air from the motors being tested at the facility. [Canoga Park]*
28. *There are many kids in our area and if there is a toxic substance that may be air born in our community we would definitely need to know. We sure don't want our kids getting weird ailments. Please be open to the community and warn us if we need warning. [Canoga Park]*
29. *Why do they let cattle graze around the test site? Who eats the cattle? We do! [Canoga Park]*

Public response from Chatsworth:

30. *A lot of the elderly who lived here either died of cancer or had skin cancer! A lot of them moved, I can't afford to move. My daughter and I are always run down, only at home! We just want to sleep all the time. I pray it isn't from the toxins in the air. [Chatsworth]*
31. *Lived at present residence 50 yrs. Wife died of colon cancer 12/24/1999. I survived bladder cancer. [Chatsworth]*
32. *My son had cancer and several animals as well. My asthma has returned after 41 years without incident [Chatsworth].*
33. *Because my wife got cancer and we live so close to the Rocketdyne Laboratory, we were curious as to the affects to the surrounding community. Maybe some waste was carried in the wind or water. We just want to know. [Chatsworth]*
34. *My wife was recently treated for breast cancer, is there a connection? [Chatsworth]*

Public comment relating to health continued:

35. *Several of my neighbors have developed neuromuscular disorders, please send me data on this if available. [Chatsworth]*
36. *I have lived in the area for 30 years. Every dog I owned was plagued by tumors. The groundwater at the reservoir area should be monitored. Local owners of animals should have statistical facts gathered in Canoga Park, Simi, and Chatsworth. I assume human medical statistics have been compiled from the area's medical community? [Chatsworth]*
37. *Three years ago I had radical prostate surgery. I am the only one in my families bloodline who had this type of cancer, what is the incidence of prostate cancer in this area of contamination? [Chatsworth].*
38. *I'm very interested in the impact on general health and specifically cancer rate in the area. My self and four neighbors have had cancer. [Chatsworth]*
39. *I have had a couple of incidence of skin cancer and wonder if there is a correlation. [Chatsworth]*
40. *When my daughter was 11 years old she had a cancerous brain tumor. She went to Chatsworth Park Elementary School. One teacher died of a blood disease, several teachers had breast cancer. The school's plant manager had breast cancer (male). Our principle died at the age of 33 of a brain aneurysm – she dropped dead. Could our school be contaminated, a “sick” school? [Chatsworth]*
41. *People on our block have been diagnosed with various types of cancers, including me. I feel this can be an environmental problem and I am interested in hearing facts. [Chatsworth]*
42. *I live in Chatsworth and have since 1976. In 1998 I developed breast cancer and had surgery, chemo and radiation. Thank God, I'm doing very well. [Chatsworth]*
43. *I've lived here nine years and last year developed cancer. [Chatsworth]*
44. *Interested if site might have caused other diseases other than cancer, such as Parkinson's Disease? I and several neighbors have contracted Parkinson's Disease. [Chatsworth]*
45. *My wife has been diagnosed with multiple sclerosis and is now completely incapable. This all started in 1971, to our knowledge there is also a neighbor that has M.S. [Chatsworth]*
46. *My father James worked there for 10 years. He was present on site when they had the partial meltdown July 1959. He walked into the reactor room in accident. He also helped with fire protection. They had him shower, gave him fresh clothes, and sent him home. They sent his “hot” clothes home in a bag for my mom to launder while she was pregnant with me. I miss my dad. He died of cancer February 1998 [Chatsworth].*
47. *My wife died at age 57 of colon cancer. We bought our current home and moved into this area in May 1958. She was 26 years old at the time. I had a malignant melanoma on my head diagnosed and operated on in October 1972. It was caught in sufficient time for this radical surgery to have saved my life. If any radiation connected from this site is ever proven to have impacted my home and life, I must know about it! [Chatsworth]*

Public comment relating to health continued:

48. *My grandfather was an EE at Rocketdyne, and died of cancer when I was one year old. My grandmother, mother, and aunt are due to receive funds from the class-action law suite reward re health related job hazards at this facility. [Chatsworth]*
49. *We have lived in the Canoga Park/Chatsworth area for over 35 years, we have had cancer. [Chatsworth]*
50. *I just moved from that immediate area. I now live in Chatsworth. I did live in Simi Valley in those hills. I lived there for 6 years. I had a tumor removed that was cancerous. [Chatsworth]*
51. *You need to answer and ask more important questions! E.g. how many people in your family developed cancer? Was there any history of cancer in the family? My answer: My Son Bob died of a rare brain cancer. His son Michael has leukemia. No history of cancer, and we researched no drugs, no smoking, no drinking. You need to insist that the Fed.'s do a thorough investigation of cancer rates in the valley. Many students lived further away in valley, but went to school in Chatsworth and Canoga Park. Many cancer victims have moved to other states. [Chatsworth]*
52. *My wife died of ovarian cancer. She commented before her death that quite a few people here died from cancer. [Chatsworth]*
53. *Above average of cancer patients and cancer deaths in our community in the past five years. [Chatsworth]*
54. *People in neighborhoods with high incidence of cancer related diseases are concerned. People disserve factual information provided by an unbiased agency, not "PR" by laboratory officials. In-depth reporting (after intensive research) must occur. [Chatsworth]*
55. *This is a very high concern of mine. I know of many people whom have died of various cancers, and have become ill, found tumors, cysts, etc (all living near this area). What is really going on???* [Chatsworth]
56. *What studies have you done on the number of cancer patients surrounding SSFL? How can I get a copy?* [Chatsworth]
57. *Need statistical and demographic information, or research the effect, especially any abnormal increase of disease, examples of cancer etc.* [Chatsworth]
58. *There are a number of individuals who have come down with cancer in the Chatsworth area. We want to know what you are doing to find out the degree of contamination and total area that is affected.* [Chatsworth]
59. *I have been very interested and concerned about this facility. Allergies in this area have been extremely bad for local citizens! What are we exposed to as residents of Chatsworth? Are headaches related to emissions from the facility?* [Chatsworth]
60. *What were we exposed to by working up there a long time back?* [Chatsworth]
My husband worked there early 50's. My husband died of kidney failure. He lost one kidney, and I wonder if his exposure could have contributed to his death? I am 82 now, a widow, and don't know who to contact, or what to do about checking this out. [Chatsworth]

Public comment relating to health continued:

61. *I am interested in any health problems that have been reported in connection with this site, and how the cleanup will take place [Chatsworth].*
62. *Many employees at the Canoga Park facility were exposed to harmful toxic substances as well as those that worked at SSFL. A lot of toxic substances used at the Canoga complex of Rocketdyne were kept secret from employees involved. [Chatsworth]*
63. *Many of our old friends and neighbors have passed away with cancer who have been raised in this area to not take this as coincidental. Needless to say we no longer drink the water from our faucets. [Chatsworth]*
64. *I worked for Hughes Aircraft Company (located immediately south of Rocketdyne). There has been an unusually high number of cancer cases in my fellow employees. [Chatsworth]*
65. *I am aware of the investigation. I am also aware of a higher incidence of cancer in people raised around this area. Do all you can! Living fairly near this site I am concerned for our health in this otherwise beautiful and historic area. Thank you. [Chatsworth]*
66. *My family has lived in this area for forty years, very concerned!! [Chatsworth]*
67. *Very interesting in knowing the facts regarding past exposure to toxins and possible negative health outcome. [Chatsworth]*
68. *I just want to know which neighborhoods, specifically, might be affected and how they are affected. [Chatsworth]*
69. *Please inform if toxic dump is dangerous! [Chatsworth]*
70. *Do an epidemiological-study now, and quickly release the results to people in the area. Computers could make this fast and easy. GPS systems can show you where and when address are put in. [Chatsworth]*
71. *Appreciate efforts to protect children of the community. [Chatsworth]*
72. *Very concerned about health issues & genetic/birth defects related to SSFL. [Chatsworth]*
73. *We live in Chatsworth by Devonshire and Mason. Are we very close to the problem area. Is this something very major that can harm our health? I also think every day toxic problems are happening everywhere and we are not aware. [Chatsworth]*
74. *I have a child now I'm worried about contaminated water. Strange how your focus changes in life, wanting the best for your child. Any information would be nice. Thank you. [Chatsworth]*
75. *As a resident of Lake Manor since 1983, I am especially interested in any issues regarding disease or health. [Chatsworth]*
76. *I live far away (several miles) from the site in question, and don't know how contamination could effect me. What kind of contamination? Atmospherics? Soil? Water table? [Chatsworth]*
77. *My daughter's hair fell-out, could this be attributed to any of this? She was born in this house, and lived here most of her life. She just turned 21 and lost her hair at end of the 8th and 9th grade. Treatment did not work. [Septo St., Chatsworth]*

Public comment relating to health continued:

Public response from Encino:

78. *What is the role of toxic substances causing multiple sclerosis? [Encino]*

Public response from Granada Hills:

79. *Although I have no epidemiological proof, as a physician, I have treated a number of people who live in West Hills who have developed unusual tumors. I believe that there are clusters of illness out there. [Granada Hills]*
80. *Rocketdyne employed my past husband from 1963 to 1965. He worked at the Rocketdyne Santa Susana Field test site for about a year. He was exposed to whatever toxic substances were released at the test site. Five years ago he was diagnosed with prostate cancer, and underwent surgery. Please let me know if you need his name, address, & phone number. He currently lives in Santa Clarita. [Granada Hills]*
81. *Concerned, re cancer, clean groundwater. [Granada Hills]*
82. *I'm very concerned - The National Cancer Society reports on 4-20-2001, that one in four people will contract some form of cancer in their lifetime. Further, three or four cases will be from environmental concern i.e. toxic wastes from the Rocketdyne Santa Susana Field Laboratory that ruin the water supply. We drink with toxic wastes and chromium etc. Burbank and Glendale has had a lot of problems with toxic wastes, chromium ruining their wells and drinking water causing cancer. [Granada Hills]*
83. *I am interested because it is a beautiful area and I would hate to think that it has been damaged. I am also curious about health issues as I worked in the area several years ago. [Granada Hills]*
84. *I was very disappointed in the executive summary of the UCLA Rocketdyne Public Health Report. It was written in part by local and well known activists. It lacked credibility, and misrepresented the findings of the report. Unfortunately, the executive summary was widely reported, not the report itself. [Granada Hills]*
85. *I used to live in Santa Susana between February 1976 through August 1980. During that time the teachers at the Knolls Elementary School were told to get their thyroid checked as they had been exposed to radiation from Rocketdyne. I remember also as a child growing up in the valley during the 1950s and 1960s that the hills in Santa Susana would light up at night as if from explosions. [Granada Hills]*
86. *I had small children and we were living near the Rocketdyne Facility. Now as adults they appear to be good and healthy. I was concerned at the time, and had friends at Rocketdyne and heard rumors regarding chemical disposal. [Granada Hills]*
87. *As a health care professional (R.N.). I am very concerned about the contamination. I feel there has been a cover-up by government agencies. [Granada Hills]*
88. *The thought of carelessness and toxic substances is a disturbing possibility. Safety should be the top concern. [Granada Hills]*

Public comment relating to health continued:

89. *Rocketdyne Santa Susana is a human tragedy that should never have been allowed to happen. Having been employed in Aerospace in the past, I can assure you that the probability of more of these situations will occur. [Granada Hills]*

Public response from Hidden Hills:

90. *Are epidemiological studies being undertaken? And by what group? [Hidden Hills]*

Public response from Northridge:

91. *I had cervical cancer in 1983, my daughter had cancer in May 2000. We have lived here since 1975. One neighbor (woman) just passed away from a metastasized breast cancer at age 53. She had lived here since 1976. Another woman that moved to Arizona but kept in touch died of lung cancer a year ago. The neighbor across the street was treated for second stage uterine cancer two years ago. I would say there is a very high incidence of cancer in this neighborhood. There are actually two more health cases I almost forgot to mention. [Northridge]*
92. *Is the facility on Nordhoff and De Soto included? I would like information on the history of the site and any airborne releases. I have lived here since 1960 and I'm curious about that. By the way, my mother died two years ago from breast cancer, is there any relationship? [Northridge]*
93. *I believe our toxic environment is the cause of many illnesses today. [Northridge]*
94. *I lead a cub-scout pack in Chatsworth that often hikes and camps in the Chatsworth Hills, including Woolsey Canyon. We have concerns with site contamination, condition of the waterways, and potential impact on wildlife. [Northridge]*
95. *We've considered moving closer to the area (into Chatsworth) but I'm not nuts about potential pollution. I think it also might affect property rates. [Northridge]*
96. *People need to know the potential toxins in the environment – especially pregnant women. [Northridge]*
97. *I have an aunt who lives up Woolsey Canyon. I would like more information re exactly which toxic substances are in question, if they have been contained, and if they were stored in drums. If there was leakage, to what extent. I would also like to know symptoms of exposure, etc. [Northridge]*
98. *We all need to be advised as to how this impacts our property and health. [Northridge]*

Public response from Porter Ranch:

99. *Please keep us informed of dangers. [Porter Ranch]*

Public comment relating to health continued:

Public response from Santa Susana:

100. *I lived at top of Rainey Road from 1987 to 1991, I was on well water. Had a few strange situations with children's health. [Santa Susana]*

Public response from Simi Valley:

101. *My brother and I have very odd health problems. Who do we contact, and what do we do? [Katherine St., Simi Valley]*
102. *I know several people who have worked there. I have also experienced the death of my father. A couple of years before my father died he begged me to have my water tested. I and my neighbors' kids used to hike up there. We once climbed inside a big barrel with some crystal looking substance. The barrel is now gone, it has been gone since 1999 or 2000. Ever since I took all those teenagers hiking and we went into that drum, three of those girls have had babies. One girl was pregnant at the time. I have a picture of where the tank was. The substance inside was a crystallized and burgundy in color. It wasn't rust. My son used to get nose bleeds all the time when we lived in the Knolls. My uncle survived a brain tumor. My grandpa died of emphysema, my aunt has all kinds of problems, and my other aunt survived stomach cancer. [Simi Valley]*
103. *One feels now that it is all too late, nothing will help in my time. I am 82 and therefore what damage is done and already over (prostrate cancer). [Simi Valley]*
104. *We have lived at this address since 1972. My wife had breast cancer; stage 2 in November 1996 I had two surgeries, Chemotherapy and Radiation in 1997. [Charing St., Simi Valley]*
105. *I am concerned. Both my parents worked at this facility, both are deceased. My family and I have lived in Simi Valley for many years. I am wondering what effect the contamination may have had on our health. [Simi Valley]*
106. *Father-in-law worked at Rocketdyne on the hill, he died of lung cancer. A lot of people on our block have had cancer or other health problems. We lived in Canoga Park area during earlier years, and I feel Rocketdyne contributed to many deaths and illnesses. [Vera Ct., Simi Valley]*
107. *A lot of people on our street have become ill, including my husband and I. [Fasley Ave., Simi Valley]*
108. *I retired from Rocketdyne in 1993. Worked at SSFL on the Space Shuttle Main Engine, Apollo, and Lance Missile. Prostate cancer removal operation in 1997. Semi annual check-ups show no further evidence of cancer. I do not know of any direct contamination to the environment by Rocketdyne. [Simi Valley]*
109. *My wife died of cancer after moving to Simi Valley. Toxic sites are always suspected. [Simi Valley]*
110. *My father died of pancreatic and liver cancer that we believe was related to exposure to the chemicals and radioactive substances located at the SSFL. [Simi Valley]*

Public comment relating to health continued:

111. *I moved into a home in the shadow of Rocketdyne and I lost a very healthy and young dog to tumors and cancer within two years. [Texas Ave., Simi Valley]*
112. *We are upset about the news that our property may be affected. We have had fertility problems and our neighbor's dog got sick. We left Burbank due to the Lockheed mess, now we are faced with more pollution. Please help us. Our friends have died prematurely of brain and bladder cancer. We don't want to end up like them. [Simi Valley, Cowgirl Ct.]*
113. *My brother-in-law lived on Beechnut Street and developed thyroid cancer from living close to the facility. [Simi Valley]*
114. *Three years ago I was diagnosed with Non-Hodgkin's Lymphoma of which there is no cure for at this time. I have lived and worked in Simi Valley since 1981. I heard through the grape vine just recently that there is a class action law suite pending regarding people getting serious illness such as mine possibly due to contamination of hazardous waste from the site. I would like more information on this to know if my residence and/or work site may have been affected. Please keep me informed. I would be happy to answer any questions on this matter. [Simi Valley]*
115. *I had skin cancer – melanoma, and knew someone with breast cancer. I'm not sure if this site produces cancer or not? Husband died of cancer. [Simi Valley]*
116. *I have had a cancerous tumor by my pancreas. My son's friend's father died of pancreatic cancer. My co-worker's parents died of cancerous tumors. She will not drink the water. Another co-worker's sister died of pancreatic cancer. Please look into people in Simi Valley having cancer, especially tumor cancers. If at all it relates to SSFL. Thank you! [Simi Valley]*
117. *Both of my dogs died of cancer. I have had cancer. [Melia Street, Simi Valley]*
118. *A number of women from my breast cancer support group would discuss their participation in various meetings relating to clean up of the site. [Simi Valley]*
119. *My great uncle passed away with cancer when I was 12 years old (I'm now 34). He was an employee at Rocketdyne. Although the family didn't make the connection at the time, I'm sure it was a direct result of his employment. [Simi Valley]*
120. *My husband worked for Rockwell and died of lung cancer. I raised 10 children while living at Katherine St. Simi Valley. I am concerned as to their and my health due to living so close to SSFL for 10 years. [Simi Valley]*
121. *We lived below Rocketdyne for 35 years. I have a nerve condition that I feel is caused by the fall-out. I have a neighbor with the same condition. [Whitewood St., Simi Valley]*
122. *What I do know is a little girl of four years old died of cancer. Numerous tumors were removed from her kidneys and stomach. [Simi Valley]*
123. *I want to be made aware of what is happening in my community. I have been a Simi resident for 29 yrs. I have had three friends die of cancer (all Simi residents). My father had a brain tumor, my mother had breast cancer. Two of my father's friends in same area of Simi developed brain tumors. [Simi Valley]*

Public comment relating to health continued:

124. *Our son and his family live on the other side of Simi Valley on Oak Road. His mother-in-law died of cancer just recently. The trailer park manager's wife in adjacent area just died of the same type of cancer. Some of these folks are on original water wells, hand dug on eastside of Simi Valley. Little is know about these wells or pollution in the area. One neighbor has an original hand dug well; I think the first one in Simi Valley. The water tank was where cattle were branded. Herding from San Fernando Valley over the old stage coach road (Rocky Peak Pass) to Simi Valley. [Simi Valley]*
125. *Worked for Atomic International and Rocketdyne for 9 yrs (1959 through 1963), and lived in my current house for the past 35 yrs. My daughter contracted and was treated for thyroid cancer at age 42. Ongoing Class Action Law Suite. [Simi Valley]*
126. *I have lived in the San Fernando Valley and Simi Valley for 51 years. A good friend of mine living in the Susana Knolls area died of cancer in her 40's. Has air been poisoned too? Yes, I'm very interested! [Simi Valley]*
127. *We live ¼ mile from the facility for the past 30 years. My health, breathing, sinus has gotten worse. [Simi Valley]*
128. *Heard about nuclear waste may have been spilled, also heard about cancer rates on that side of Simi Valley. [Simi Valley]*
129. *Several years ago I read about an increase in leukemia cases on the southeast side of Simi Valley. I am concerned that our drinking water and/or ground contaminants are causing it. We lost a good friend in his late 40's to the disease. [Simi Valley]*
130. *I have heard of concerns about the health of people who lived near the facility. Higher cancer rates, especially bladder cancer in men who lived on the west hills side of the site. [Simi Valley]*
131. *I heard incidents of blood cancer are many times greater among residents in areas around the site. We live in the basin, and would like more information about this effect plus water hazards, etc. [Simi Valley]*
132. *We are concerned over the many friends and animals that have come up with cancer after living in this area. [Simi Valley]*
133. *Do you have any maps that pinpoint the location of cancers? [Simi Valley]*
134. *I don't think enough is being done to cleanup this area. Also, there is a high incidence of mental retardation, Twitte's Syndrome, autism, thyroid disease, and breast cancer in the east end of Simi, Texas tract and Indian Hills, especially in children. Check out the schools in the area. [Simi Valley]*
135. *I am extremely concerned about a report I had once heard about the unusually high amount of cases of cancer of people living in the eastside of Simi Valley. It was assumed to be a direct result of the SSFL. [Simi Valley]*
136. *Please keep sending information to us. Over the years, even before a lot of information started appearing, we observed many deaths near White Oak Elementary area on Alscot and Nelda. [Simi Valley]*
137. *Heard a lot about cancer in our area, unusual kinds. Heard of a lot of children's learning disabilities in our area also (children now grown to college age & past). [Simi Valley]*

Public comment relating to health continued:

138. *I understand that the Simi Valley Unified School District Adult Education is conducting an environment test. Our site (Adult School) has been tested. The Adult School has had high incidents of cancer and other diseases. We at the Adult School feel our environment has toxins. Many of us live in Simi and work in Simi. [Simi Valley]*
139. *As a result of this chemical and radioactive contamination are there any unusual or high rates of cancer or other health problems in the area around the Rocketdyne site towards the areas of east Simi Valley, Santa Susana, Bell Canyon, and west San Fernando Valley? If the answer to the above is no, then this is much ado about nothing. If it is yes, then what is the delay in cleanup? [Simi Valley]*
140. *I know that there has been a very high incidence in cancer for many people in Simi Valley. Perhaps its cause was Rocketdyne and the runoff into the water system. [Simi Valley]*
141. *Our family lived at Crown Hill Rd, Simi for 16 years. One of the closest homes to Rocketdyne. My main concern is my families' health in the future, as I know that many of my former neighbors have health problems! [Simi Valley]*
142. *I have worked for the Boeing Company for over 25 years. There has been information passed through the division about hazardous materials at SSFL. I machined end fittings for nuclear reactor fuel elements and was exposed to low level radiation once. If there were a way to screen for cancer (full body CT) I would entertain the opportunity. [Simi valley]*
143. *DTSC should actively seek out local occupational health groups, American Association of Occupational Health Nurses, and the American College of Occupational and Environmental Medicine to have speakers at meetings on the status of occupational issues that occurred for workers at the Santa Susana Field Laboratory. These groups need to be included because of where they are positioned in the community to get the word out. [Simi Valley]*
144. *Our family is concerned that the town and surroundings are thoroughly examined. None of us want to raise our children in an unhealthy environment. Thank you for your services. [Simi Valley]*
145. *We would like to know any information regarding the risk to my family living so close to the SSFL. [Simi Valley]*
146. *Contact medical doctors, hospitals, and veterinarians to find out what type of health disorders are much higher out here compared to Thousand Oaks, Santa Barbara etc. [Simi Valley]*
147. *Concerned whether this contamination can cause birth defects? I have a current lesion in my fetus. [Simi Valley]*
148. *Just close it down & clean it up! I know lots of people that have cancer around here. Close it down and clean it up! [Simi Valley]*
149. *I use the Sage Ranch Park daily. I am running right next to the facility and wonder if it is safe to breathe the air? [Simi Valley]*
150. *I would like to know if the toxic substances in question pose a serious health issues to this community. Is groundwater affected etc. [Simi Valley]*

Public comment relating to health continued:

151. *I'm concerned about my own health due to the SSFL problem. I have lived in our family home since 1962, and I'm the last of my family. I can't afford to move, and I don't have any health insurance at the moment. I've read a great many things about this problem, and I believe that my health is being compromised by this ongoing problem. [Simi Valley]*
152. *We find it confusing how a case of cervical cancer, or lung cancer in a smoker, could have triggered the kind of investigation that we as tax payer's are now being made to pay for. [Simi Valley]*
153. *The work done at SSFL was essential for the security of our country, and the test reactor, rocket testing and hot-cell testing was something that got us on the moon and improved our lives. There is no danger to the public unless they live at the base of the mountains and drink well water (maybe). I have lived within its influence area for 31 years and it has not affected mine or anyone else's health. [Simi Valley]*
154. *This has not affected me and I have no further comments [Simi Valley].*
155. *This concerns me a great deal because I've lived right in the area for years. Where is the contamination? I'm hoping it won't affect my health. [Simi Valley]*
156. *After presently living in the general area of the facility for years, I am concerned re health problems, etc, and the cleanup delay. [Simi Valley]*
157. *Be honest and true, is our drinking water safe? What is my health going to be? [Simi Valley]*
158. *I don't believe that this site is cleaned up. A proper epidemiological study should be done in the area near by. [Simi Valley]*
159. *Please let us know if the water is bad to use for showers and baths. They used to dump toxins into our water supply. We try drinking bottled water only. [Simi Valley]*
160. *I have concerns for water table water runoff into drinking water. [Simi Valley]*
161. *We need to make sure the land we live on is not toxic for the health and safety of all our children. [Simi Valley]*
162. *I am concerned because I lived below Rocketdyne for 20 + years, I also worked in Chatsworth for 20 years. [Simi Valley]*
163. *Please make sure the local schools, especially Katherine and Knolls Elementary Schools are safe regarding air, water, ground, etc. [Simi Valley]*
164. *Why does it take so long to do so little, these big Corporations get away with murder. They care only for money, not people. [Simi Valley]*
165. *I currently moved to the Simi area. I have a two-year old son. This is why I'm concerned. [Simi Valley]*
166. *I'm interested in anything connected to where I live, especially if it is health related, and if I can do anything to help improve our City and health. [Simi Valley]*
167. *We have the feeling that the public has not been told the complete truth and that facts regarding health risks have been minimized to prevent public outcry. We would appreciate a more asserted effort and complete disclosure. Thank you. [Simi Valley]*

Public comment relating to health continued:

168. *Please mail me any information regarding exposure symptoms, locations of highest concentrations, etc. Thank you. [Simi Valley]*
169. *Does the Ventura County Public Health and other Departments have all the pertinent information regarding your efforts and possible long term health risks? Simi residents are very concerned, though haven't heard of any County programs addressing this issue. I am a public health nurse for Ventura County, I see clients in Simi Valley. [Simi Valley]*
170. *This situation is overblown. Just because people have cancer does not mean that someone is responsible, or that a responsible party exists? [Simi Valley]*
171. *I recently moved to Simi Valley, resident for 1 year. I am very concerned about living next to Rocketdyne: (1) Are there hazardous substances at the SSFL? (2) Living next to the SSFL is there a risk to nearby neighbors? [Simi Valley]*

Public response from Susana Knolls:

172. *I have lived in sight and hearing of Rocketdyne since 1957. I and all my four sons have been ill. All of us have had heart defects, high blood pressure, asthma (me), coughs, allergies (exema), eye infections, diabetes (me), high anxiety, sleeplessness, and memory loss. Last child was born with no trachea and esophagus, two sons died at 4 months. [Alta Vista, Susana Knolls]*

Public response from Tahoe City:

173. *I have lived in the West Valley area since 1960. I am interested in any known public health issues. [Tahoe City]*

Public response from West Hills:

174. *My father just passed away after living in the area for over 40 years. I am interested in this since I have been living in the area for over 30 years myself. Thank you. [West Hills]*
175. *I have lived directly below east of the facility for 45 years and have many health problems and I'm confined to a hospital bed at home. We have a pool, for 45 years I was outside almost 10 hours a day. The testing went on constantly. Steam etc drifted down with the wind. Now I have many health problems. I believe that the years of exposure are the problem. [West Hills]*
176. *Four men on my street have died of cancer near Valley Circle and Victory. [West Hills]*
177. *I have bladder cancer, which I feel is directly attributed to the radioactive waste discharged by Rocketdyne. [Bobbyboyar Ave., West Hills]*
178. *I have a son who was born with Lynphangioma and henangioma tumors and Cystic hygroma which may be related to the activities at Rocketdyne. [Dennis Lane, West Hills]*
179. *I am concerned that my son contracted Chrons disease due to this. [West Hills]*

Public comment relating to health continued:

180. *In February 2000, I was diagnosed with breast cancer, I had surgery in March. Since there was cancer involvement in my lymph nodes, I underwent three and a half months of chemotherapy followed by 5 weeks of radiation (Monday through Friday). [Neddy Ave., West Hills]*
181. *I worked at Rocketdyne, my doctor said my bladder cancer was from the 'Hill.' All my neighbors died of cancer all had kidney cancer & tumors. [Ponce Ave., West Hills]*
182. *I accidentally let my dogs drink from the Chatsworth park stream, it caused cancer and tumors. I cut short my one dogs life. When the winds blew it affected my allergies and medicine didn't work or help. I was told that it was your site that made me sicker then normal. My partner and his good friend had brain tumors, the one friend died. [West Hills]*
183. *Three neighbors have died of cancer living many years within 500 feet of our residence. We have had three dogs and one cat die with tumors and cancer in the last 10 years. They all lived out of doors. One additional neighbor now has lung cancer. [Kentland Ave., West Hills]*
184. *We moved to our home in 1999, and now there are three neighbors that live across from us who have cancer. I don't know if they got it from somewhere else. I have never lived where people around me in different homes have cancer [Ellenview Ave., West Hills]*
185. *My husband died of cancer. I'm very worried about the toxic problem. I raised my family here. We never dreamed. [Maestro Ave., West Hills]*
186. *We have lived here since 1967. We know of illness and cancer. My daughter has an immune disease and my husband has lupus of the skin. I think this is because of contamination from the site. [Valley Circle Blvd., West Hills]*
187. *Me and neighbors have had cancer. My address was once Canoga Park. Has now been changed to West Hills. [West Hills]*
188. *My wife was diagnosed with breast cancer 9/8/1998. Could this be related? [Bobbyboyare Ave., West Hills]*
189. *How does this effect our property value, and the quality of our water? I am concerned about the drinking water causing cancer. Have heard filters are not effective with the water from the area. [West Hills]*
190. *Lived in the area since 1965, and have observed high rate of leukemia. [Mobile St., West Hills]*
191. *We have a son who is disabled due to extreme chemical sensitivity. Did it occur due to the drinking water? [West Hills]*
192. *Strange smell at night between 11 p.m. to 5 a.m. [Farralone Ave., West Hills]*
193. *I am very concerned about health risks. [West Hills]*
194. *As an individual who grew up within close proximity to this site, I am very eager to acquire information with regards to health issues, past and present. [West Hills]*
195. *I only know if any toxic substances are found they should be taken care of. When I moved here, I thought it safe.[West Hills]*
196. *What is being done re: exposure in 60's, 70's etc? [West Hills]*

Public comment relating to health continued:

197. *We are parents of two children and our family enjoys hiking in the hills and trails above our home and below SSFL. In the first year we lived in the area, our children waded in small waterfalls and creeks below SSFL, which we subsequently forbid them to do again, but we are worried about potential exposure risks. [West Hills]*
198. *As a resident property owner of 35 years, what consequences and effects has this had on me? [West Hills]*
199. *We have lived here 34 years. When land around here was vacant, we used to see strange green glowing ground level clouds or balls at night. This is consistent with radiation release. This is now a high cancer area, I known for bladder, lung, and colon cancer, etc. [West Hills]*
200. *I would like to know what dangers were back in the 60's and 70's. [West Hills]*
201. *I am concerned about any medical ramifications. I would appreciate being contacted in this regard. [West Hills]*
202. *After 35 yrs of living fairly close to the SSFL, we are concerned. Working at Simi High School also poses a concern. Any effects on water supply? [West Hills]*
203. *Parents, schools, and teachers should be involved in concern of what effects could be caused to our health and our future generations. What things are being done to protect future health and our children's future generations? [West Hills]*
204. *I am concerned because I worked at the SSFL from 1960 to 1965. If I were exposed to any toxicity I would be interested in any precautions I should take. [West Hills]*
205. *I am concerned about the site's contamination and its impact on the health of my family and the community. [West Hills]*
206. *What are the current health dangers to me and my family, if any! [West Hills]*
207. *I want to know if living in Northridge for the last 43 years has endangered my life and health. [West Hills]*
208. *We have lived in this home since 1968. Spouse was diagnosed with bladder cancer 5 yrs ago. We are concerned about the toxic substances from SSFL and their possible link to serious illness. [Burton St., West Hills]*
209. *In 1995 my wife of 49 years passed away! She spent most of her life in this house! She did not work. She tended our children and spent time with the PTA and other activities with the school. When she passed away, every organ in her body had failed! All the records are at UCLA Medical Center! It is suspected the fall-out from Rocketdyne was partly to blame for the failure! However, no one knows for sure. She was 71 years old at the time. [Quimby Ave., West Hills]*
210. *My dad worked there. He also died due to radiation exposure. My parents filed a workman's compensation claim and it was dismissed because BOEING attorneys lied about what went on up on the hill. [West Hills]*
211. *I have had a cancer, and I'm concerned for my wife and kids. [West Hills]*
212. *My mother lived in the area for 30 yrs and died from cancer of the lungs? [West Hills]*
213. *My wife has developed "Lymphoma" since moving to West Hills in 1993. We would like to know if this has any relationship to contamination? [West Hills]*

Public comment relating to health continued:

214. *I'm not sure if it's the same SSFL but my friend's sister had cancer because of some toxic elements in the Simi Valley area when they were growing up. I'm definitely interested in any contaminants that would endanger my son's and the rest of my family's health. [West Hills]*
215. *In the past 2 yrs we have had three cats that died from heart failure. All were young (1 -2 yrs old) and well cared for. Vets have said this is highly unusual. Moorcroft Ave., West Hills].*
216. *I have been at this address since 1961. I am concerned as to what extent this has affected my four children. One of which is a Downsindrom child. [West Hills]*
217. *My concern is the health of living beings in the contaminated areas. I suffered cancer between 1994 and 1996. I just hope this was not the cause. [West Hills]*
218. *The east-end of Simi and the west-end of the San Fernando Valley have a higher rate of cancer per capita compared to the rest of the U.S. The land where we hike and ride bikes is contaminated and we were never told. This cover-up has been going on for 40 years. Business needs to take responsibility from mistakes. Accidents happen with progress, but inform the people when they occur. [West Hills]*
219. *I would like to know about any potential health risks and studies documenting cancer rates and types occurring or have occurred in this area surrounding the SSFL! [West Hills]*
220. *I am extremely concerned about the abnormally high incidents of autism, and speaking disorders around Woodland Hills and West Hills. [West Hills]*
221. *1961, 1962, or 1963, I know a meltdown occurred. Many people have contracted cancer due to the cover-up. [West Hills]*
222. *I know of high incidents of certain types of cancer from airborne releases of toxic fuel burn-off. [West Hills]*
223. *Of approximately 20 homes of 69 Hundred Block of Melba Ave (91307) a quick estimation shows that 12 seniors (55-70) died of various cancers. Is this above average? Any explanations? [West Hills]*
224. *I live very close to the facility and need to know if I'm in any danger of contacting cancer or other diseases from contamination. [West Hills]*
225. *With so much cancer among our relatives and friends, it is of great concern to us that hazards such as you mention should be eliminated. What good is a beautiful area if it is unsafe to live in? [West Hills]*
226. *I am fairly concerned about high cancer rates in our neighborhood, and would certainly have more peace of mind knowing that some concerted cleanup effort is underway. What are the toxic chemicals causing so much harm? [West Hills]*
227. *I know there was a meltdown in the 1950's. I grew up around the block from the Chatsworth reservoir. So many of my neighbors died of cancer. [West Hills]*
228. *Sage Ranch is where we take youth on overnight trips, is it safe to do so? [West Hills]*
229. *Please let me know of illnesses discovered in the covered area. My family has lived here since May 1969. [West Hills]*
230. *As a 30 year resident in the affected area. My entire family has concerns about the possible exposure to any materials which might harm us. [West Hills]*

Public comment relating to health continued:

231. *I am interested in knowing the SSFL's effect on public health in West Hills. [West Hills]*
232. *What is my health risk? Should I be drinking bottled water? Do water filters protect me? Your map is very vague. I want to know exactly the names of the streets surrounding it and which direction the water flows from it. [West Hills]*
233. *I would like information on how contaminated the facility is and how it can effect me and my children. [West Hills]*
234. *I am very concerned about the potential health hazards to me and my family. I would like to be kept aware of what is happening with the cleanup. [West Hills]*
235. *If this is something that does or can have an effect on our health because of where we live, please advise me. [West Hills]*
236. *I am interested in any information that relates to health risks for the area I live in. My wife and I have lived in the same location (near the Platt Branch County Library) for over 35 years. [West Hills]*
237. *As I enjoy growing vegetables for the family, should I be concerned about contamination? [West Hills]*

Public response from West Village:

238. *I'd like to know findings for people who lived there in 1970 through 2000. Any health problems reported!! [West Village]*

Public response from Winnetka:

239. *I have been diagnosed with a very rare cancer of the pancreas in which is now being treated. My doctor does not know how I got this. [Eccles St., Winnetka]*
240. *Thanks for keeping us informed. I am very concerned about health-related issues for my family. [Winnetka]*

Public response from Woodland Hills:

241. *My wife has had colon cancer, and I have had skin cancer six times. [Philiprimm St., Woodland Hills].*
242. *I, along with 60 + others that I know of within a 5 mile radius of SSFL have contracted cancer. [Friar St., Woodland Hills]*
243. *Very concerned about the health effects from the testing site. Especially since we have lived in this area for 42 years (since 1960). I would want information as to what to look for regarding our health. My family has had cancer and I'm wondering if this could be due to testing in early 1960's. Need to know progress of cleanup and how it affects us today. [Crossen Drive, Woodland Hills]*
244. *I'm very interested in being added to your database as my daughter has suffered with two bouts of cancer requiring removal of her thyroid and one breast. Plus there are other facilities in the West San Fernando Valley that also need to be investigated. [Woodland Hills]*

Public comment relating to health continued:

245. *It seems that all or most people 50+ yrs old in Valley Circle Estates are getting cancer and many have died. These cancer diseases could be a result of Rocketdyne's facility. [Woodland View Drive, Woodland Hills]*
246. *We are concerned that so many cases of cancer are appearing to the north of us. We recommend a complete medical survey and study of all residents within a 5-mile area of the site. [Woodland Hills]*
247. *Someone living in our West Valley area once told me he knew of an unusually high number of cancer victims in this area and he insisted that it was due to the Rocketdyne Santa Susana Lab. [Woodland Hills]*
248. *When my husband worked there, they knew of the spill, but did not know it was a health threat. My husband was dispatched to the SSFL by his local union. They refused any help in this matter, my husband died, May 18, 1986, of leukemia. [Woodland Hills]*
249. *My concern would be for previous employees, which I believe you are evaluating now. We are all interested in environment, but there should be definite limitations that companies should be responsible for. [Woodland Hills]*
250. *The word needs to get out that there are too many sick people! [Woodland Hills]*
251. *Do the large amounts of cancer cases in our neighborhood have any relation to what is going on? Breast cancer, prostate cancer, and brain cancer! [Woodland Hills]*
252. *I think there should be a study of the health of long-term residents who live or have lived within a five-mile radius of the site. [Woodland Hills]*
253. *I am 68 and in good health. I believe the concern over SSFL has been blown out of proportion by adjacent property owners. [Woodland Hills]*

Public response – no name or address given:

254. *I believe Rocketdyne's testing for many years may have been a contributing factor of my developing thyroid cancer. [no address given]*
255. *My husband had the vehicle maintenance and repair contract with Rocketdyne. Needless to say, he and his employer in Canoga Park made the trip many times a day driving down vehicles and returning them. He died in 1974 of cancer at the age of 54. [no address given]*
256. *I have health concerns regarding this site and wonder how they are to be addressed. My husband passed away from brain cancer, and I have wondered if there is any relationship?[no address given]*
257. *Since moving to Granada Hills in 1985, I have developed severe lupus. I am interested to know the link between autoimmune disease and this site. [no address given]*
258. *Are incidents of cancer on the increase within the field laboratory environment? We both have developed cancer in the past seven years. We have lived at the current address since January 1969. [no address given]*
259. *I am worried about toxic leakage and cancer affects. [no address given]*

Public comment relating to health continued:

260. *I'm concerned about Rocketdyne's illegal waste disposal and neighbor's deaths from cancer in my neighborhood, women and men alike. I have also have been diagnosed with cancers. [no address given]*
261. *This facility has subjected all the West Valley residents and their children to perils they were not familiar with. They have caused cancer, mental retardation, and birth defects, all of which produced untold human misery, heartaches, sorrow, and pain. Our water supply is poisoned all the way to the ocean. Clean up is not possible! All we can do is diminish future effects. [no address given]*
262. *Contact hospitals, clinics, doctors, churches, with fact sheets and offers of free exams for lung, blood, or other related disorders. [no address given]*
263. *This is very important and we need to know exactly what problems could occur to our health as a result of what takes place. [no address given]*
264. *I don't feel any further need as I am now assured the tap water is safe enough in my vicinity and you can dispense with sending any more material or notices. [no address given]*
265. *Please keep me informed if any serious health hazards would be in existence. [no address given]*
266. *I am only interested if we are in danger of anything that would hurt us. [no address given]*
267. *More than 30 years have passed since I was exposed to the so called radioactive soil and buildings, and no illness that is usually connected with this exposure has shown up. [no address given]*
268. *Residents of immediate area are concerned about: (1) Drinking water being contaminated, (2) Streams and rain water run off that occur annually (some times the water run off looks contaminated, I'm curious if it is tested), (3) The general health and safety of our children in this area. [no address given]*
269. *I would like to know the levels of toxins and what types, and how they may effect the public. What types of preventative care can be taken? [no address given]*
270. *I am extremely concerned about the long term effects. Currently, LAUSD often has meetings near the location. I try to avoid going to that area. [no address given]*
271. *Having grownup in the area and hearing about accidents and testing done has always concerned me. [no address given]*
272. *How does this issue effect me? I live in Granada Hills, 10 to 15 miles and one mountain range from this site. [no address given]*
273. *Distance from the site, and the fact that most strong winds are from north to south make this of a lower priority this far-east. [no address given]*
274. *I have no concern other than my property is far enough away I should not have a problem but feel for people in the immediate area. [no address given]*
275. *My husband and I do not consider our family at risk from contamination from the Rocketdyne site. Are we misguided? [no address given]*
276. *After 17 years of employment at Atomics International, I am still as healthy as a horse. I am now 88 years old. [no address given]*

7.3. Public comment focusing on cleanup activities

Number of Public Responses 244 (7 %)

Note: All public comments are unabridged direct quotes.

Public response from Bell Canyon:

1. *I am an Environmental Engineer and I'm quite concerned about possible toxic and radioactive materials that may have contaminated the SSFL and are being released into the environment. I am particularly concerned because Bell Creek runs through my property, and that the SSFL may be located in the watershed from that creek. [Bell Canyon]*
2. *When will the problem be eliminated? [Bell Canyon]*
3. *I still believe my property is contaminated by runoff and groundwater seepage and natural springs which drain on my property in Bell Canyon. Analysis of water shows high metal content, including chromium. [Horseshoe Lane, Bell Canyon]*

Public response from Canoga Park:

4. *I know it exists and there is a question of how much contamination there is, but I do not know specifics. [Canoga Park]*
5. *Cleanup should have a time limit for completion. [Canoga Park]*
6. *What types of toxic substances are located at the site? [Canoga Park]*
7. *What is the air around the site like? [Canoga Park]*
8. *I live in a mobile home near the site, therefore would like to see site made safe. I buy all drinking water and cooking water. [Canoga Park]*
9. *I am interested if the toxic cleanup may have any long-term affect on me, or my wife's health. My concerns may be for no good reason, but I would like to know for sure, and would like to remain informed of any new findings. [Canoga Park]*
10. *Our mobile home overlooked the road and we observed trucks hauling materials away on many occasions. [Canoga Park]*
11. *Do their actions at the SSFL affect our bathing and drinking water? What are the other possible effects, if any? Is this a danger or hazard to my family in any way? [Canoga Park]*
12. *We had some sort of caustic substance in our water pipe coming in directly to the house. I made the mistake of handling some of it, the skin on my hands turned white and I experienced a strong burning sensation. My husband confirmed that this substance burned my hands when he held a small piece between his thumb & finger in which he too received a burn. We don't drink our water because it burns. Department of Water and Power sent someone to test our water. We requested test results without any response from them to date. [Shoop Ave., Canoga Park]*
13. *I'm concerned about our drinking water being contaminated. [Canoga Park]*
14. *It is my opinion that any information related to the contamination should be given to every person. Thank you. [Canoga Park]*

Public comment focusing on cleanup activities continued:

15. *I'm very concerned about contamination and cleanup activities. [Canoga Park]*
16. *I am very concerned about the toxicity of our water. I cannot drink water from the tap because it is discolored and tastes very bad. I wanted to buy a house around this area, but now I don't want to. My neighbor's family and friends are also very concerned with Rocketdyne and how they dumped toxins around Woolsey Canyon. [Vassa Ave., Canoga Park]*
17. *I have had numerous past employees tell me how the toxic waste and chemicals were dumped throughout the area. Employees were told not to say anything, and had to sign papers. I used to live in Box Canyon, Chatsworth from 1974 through 1979. We are all concerned about the dumping that went on for years. [Canoga Park]*
18. *I'm concerned about cleanup efforts and toxic seepage into the water table. I have a farm plot. [Canoga Park]*
19. *I'm interested in the progress of cleanup. I frequently hike and visit parks in the area. [Canoga Park]*
20. *I am very interested in all environmental cleanup efforts near or around my area of residence. Thank you for including my family in this survey. [Canoga Park]*
21. *I am interested in what happens with the cleanup and groundwater contamination. I'm concerned about any health issues as well as the possible loss of value in my properties. [Canoga Park]*
22. *1. Cleanup must be performed fully and to the highest standards. 2. Full disclosure of all past incidents must be made. 3. A full description of plan and progress should be maintained. Make available on Website. [Canoga Park]*
23. *I would like to know where the underground polluted water is moving to. Especially if it is expected to penetrate Canoga Park. [Canoga Park]*
24. *SSFL should be cleaned up to its original condition. If SSFL does not cause higher incidents of cancer (prostate) or others, then what caused it? Many years ago a study was made that said high incidents of cancer near SSFL were not caused by SSFL contamination. How can you be sure of this? [Canoga Park]*
25. *I was wondering if the radioactive waste and rocket fuel can make its way into the drinking water supply? [Canoga Park]*
26. *Our prevailing winds come from that direction. That's my main concern. [Canoga Park]*
27. *Please keep me up to date of any hazardous materials, vapors, or the like, since I do a lot of hiking in that area. Plus, I am concerned of the damage to the animals/birds in that area! [Canoga Park]*
28. *Inform the people of Simi Valley and San Fernando Valley about levels of Uranium and radiation levels in the drinking water measured in pgi/L and compare with health standards. Explain to what extent SSFL is responsible for the high unhealthy levels and what measures will be taken to eliminate the problem. Mail results to all residents in the area! [Canoga Park]*
29. *To me it seems it should be relatively easy to discover some dangerous toxic waste in our homes and around them. Notify us that we are in danger and figure out a way to get rid of it and prevent it from happening again. [Canoga Park]*

Public comment focusing on cleanup activities continued:

Public response from Chatsworth:

30. *I think that the cleanup work is already adequate. No more taxpayer's funds should be spent on this cleanup program. [Chatsworth]*
31. *Have we at Rockpoint in Chatsworth been exposed to any harmful elements? What distance is considered safe? [Chatsworth]*
32. *I see many trucks transporting who knows what out of the site. I think the local residence should be informed when this happens. I have lived here most of my life and I'm raising two children here. I think it should be cleaned up ASAP. [Chatsworth]*
33. *I would like to know if the airborne contaminants have poisoned the earth or land around this area. [Chatsworth]*
34. *Is the water table all contaminated as well as in the air? How does this affect my family health? I have lived in the area for 30 years. [Chatsworth]*
35. *The level of toxic or radioactive contamination at this site poses such an extremely low level of exposure to the public that the level of concern promoted by anti-nuclear, anti-scientific luddites and publicity-seeking politicians and "journalists" is not justifiable. [Chatsworth]*
36. *Gee, is this why Chatsworth Lake was never opened as a recreational facility as was planned in the sixties? Was it a dump for the radioactive waste from the meltdown? Or was it just too close and downwind? [Chatsworth]*
37. *I have lived in Chatsworth for 35 years, and would like to know the reason why they were allowed to dump there waste in those hills for so long. My dad and I are licensed by the Los Angeles County Health Department for swimming pools, and have had to follow the rules with no problems, how can a place that big get away with it? [Chatsworth]*
38. *What has been done to protect my family from contamination? Is there a short or long term implication? [Chatsworth].*
39. *I lived below Rocketdyne on Wolsely Canyon for 4 years. I'm concerned about the drinking water contamination in that area dated between 1983 through 1987. [Chatsworth]*
40. *What we did in the past in the name of national security may have had some justification. When profits by companies are considered without regard to the contamination of our environment by so called executives, this should be considered a crime. A cleanup for their past sins should be paid for by them, not the tax payers. [Chatsworth]*
41. *We are very close to this and want to make sure everything is okay. We have been having trouble with our water smelling like rotten eggs [Chatsworth].*
42. *What are they doing to cleanup this site, and how does water contamination effect our area. [Chatsworth]*
43. *Clean it up, please. [Chatsworth]*
44. *"North American Aviation" now "Boeing" knew for years of contamination at this site. I was employed by N.A.A. for 13 years, 1955 to 1968. [Chatsworth]*
45. *I believe the project should have been cleaned by now. It is moving too slow. [Chatsworth]*

Public comment focusing on cleanup activities continued:

46. *I have tended to feel that the cleanup has been extensive. But I know a group of people who are very concerned. You might consider offering to meet with them. [Chatsworth]*
47. *I am very interested in the environmental condition of the land. I encourage SSFL to stay and continue their worthwhile and economic beneficial activities. I would like to see NO future development of the hills and we should retain all the open space possible. Groundwater contamination and long-term health affects are a concern. Thank you. [Chatsworth]*
48. *(1) When will we know what the contaminants are? (2) How far have they spread? Are the contaminants in our water or air? (3) What can be done about it? (4) When will the remediation begin? (5) When will it be completed and to whose standard? [Chatsworth]*
49. *We don't have any definitive knowledge of: (1) What are the contaminants? (2) What are the acceptable levels? (3) What is/will being done about this issue? (4) Why does it take my postage to send back this survey? [Chatsworth]*
50. *I would be interested to see the contamination levels on site as well as down stream in the nature preserve and down on the Simi Valley side. I would like to see groundwater testing, and to see how much the levels drop coming to the Chatsworth Park side. Mapping would be nice! [Chatsworth]*
51. *Questions: (1) Is our water being tested for contamination? (2) Has there been a large amount of radiation released from this facility (SSFL) that we as residents of Chatsworth need to take action ourselves, as I have a "very high" concern and level of interest. (3) What site cleanup activities have been done? [Chatsworth]*
52. *Would like to know about ground water contamination movement. [Chatsworth]*
53. *Need to send area residents results of study, risk factors still present, future work, and final cleanup dates. All in plain English, sent to homes! We have no time to attend meetings or visit repositories. [Chatsworth]*
54. *I would like details about how cleanup is specifically being done. [Chatsworth]*
55. *Let me know how bad my property has been contaminated. [Chatsworth]*
56. *I have not visited the sites. I am uncertain of what danger was imposed on Chatsworth. [Chatsworth]*
57. *This situation of possible water contamination is very distressing to me and my community. We all want answers as to the level of toxins in our water [Chatsworth].*
58. *Please send a brief description of the type of spills, when they occurred, extent of spills, and what was done to clean up the material. Can it effect water and soil at our homes? [Chatsworth]*
59. *Dear Sirs: I worked at the field laboratory (Rocketdyne) for nearly 35 years from 1956 to 1990. I worked in all four areas. To my experience, I observed that all ground that may have been contaminated with foreign materials had been excavated down to 15 or 20 feet. Any contamination found was removed and placed in fifty-gallon steel drums, and such drums were painted yellow, marked with stencil and a code. These drums were removed by order of the government. [Chatsworth]*
60. *I was not aware of the cleanup; I'm glad it will be done. [Chatsworth]*

Public comment focusing on cleanup activities continued:

61. *Please provide comment on monitoring, drift, density, scope of contamination, and severity of it. [Chatsworth]*
62. *If you are going to travel so close to residential areas, then a lot more care needs to be exercised in the method of transportation, type of container, and precautions such as container covering. The speed of the vehicle through residential area is also a concern. Also have an EPA official riding shotgun with every transport, only then would we feel safe. [Chatsworth]*
63. *This is a major hazard in the area. It is potentially another Love Canal. I won't sell property in the Woolsey Canyon, and I think the residents there should be relocated and compensated until the cleanup is completed. [Chatsworth]*
64. *Since my home is (according to the map, and what I have read) about 4 or 5 miles from Rocketdyne. I sort of have the feeling that I am not subject to much contamination, but I am still interested in knowing about the progress of the "cleanup" efforts, or reasons for the delay. [Chatsworth]*
65. *We would like to know of any precautions that should be taken in the area outside our homes, and also when our vote is needed to insure safety. [Chatsworth]*
66. *I am very interested in the environmental cleanup, and would like to be kept apprised of this situation. [Chatsworth]*
67. *Is the drinking H2O in this area safe? [Chatsworth]*
68. *Was this site in existence in 1992? What substances are dumped there? Why are we just now finding out that this site exists? [Chatsworth]*
69. *Is there a toxic danger? [Chatsworth]*
70. *Stories about sealed steel containers full of poisoned dirt rolling through our neighborhood streets filled with the most toxic compounds imaginable without so much as a police escort, it is most disturbing, and makes me want to sue somebody. Did anybody try to notify the residents of Chatsworth what would happen had even one of those containers been spilled? What happened to the Santa Susana Mountains in the name of progress, industry, and national defense, should have been dealt with as crimes against society. [Chatsworth]*
71. *This so called cleanup has been going on for a few years. Let's resolve this as soon as possible. [Chatsworth]*
72. *I've lived in Chatsworth for over 30 years. We are concerned about toxins in the soil, water, and air. I wonder if our health is in danger?[Chatsworth]*
73. *I had no idea this was there, thank you for notifying me. I would like to know more, what they do there, what kind of hazardous materials they use, and health issues involved. Thank you. [Chatsworth]*
74. *How is groundwater being affected? What is being done to render waste products non-toxic. How is it affecting the air we see and breath? [Chatsworth]*
75. *I grew up at the foot of the hills where the SSFL is located. We played in the streams and waterfalls in that area a lot. I am concerned re: the findings about contamination, health side effects, and cleanup etc. [Chatsworth]*
76. *I want to know if the groundwater in the northwest San Fernando Valley has been contaminated by Rocketdyne's activities. [Chatsworth]*

Public comment focusing on cleanup activities continued:

77. *This issue is a two edged sword. I have little doubt that the site is contaminated, and that the damage done would be extremely hard to “cleanup.” The rocks in this area help the contaminants flow away from the SSFL and into the ground, just like the rain moves along the rock veins. It’s hard to cleanup decades of toxic run-off, especially now that there are so many homes in the direct surroundings. I’m not even sure that the government, or Boeing, would allow information that was detrimental to them to be released. For the safety of my children and pets, I would be interested in knowing more. [Chatsworth]*

Public response from Encino:

78. *I am aware that contamination has been detected. I am not aware of any cleanup activities, I’m only aware of paper pushing. You need to: (1) State whether your agency is a State, County, or City organization. (2) State whether your “DTSC” is the lead cleanup department, or just some polltaker. (3) State actions taken, and which entities took those actions. Has any actual land cleanup been done? If so, what? [Encino]*

Public response from Granada Hills:

79. *Please send us vital information regarding what type of facility the SSFL is or was. What kind of work did they do? What is so “hazardous” about it? [Granada Hills]*
80. *As an environmentalist and a taxpayer, it concerns me that biohazardous radioactive toxic waste contamination has occurred, and that the public may get stuck with paying the cleanup costs. [Granada Hills]*
81. *Any environmental analysis should involve collecting all relevant published literature particularly involving the earth sciences. There is a large collection of papers on regional winds (coastal sea breezes and Santa Anas in particular) at UCLA Dept. of Metrology and US Weather Bureau. Any digging to remove contamination should only be done summers when Santa Ana winds are minimal. [Granada Hills]*
82. *I am unaware of this situation. This is my first notice of this cleanup. Please send general information on what this is about. [Granada Hills]*
83. *My biggest concern is groundwater contamination. I don’t know if my home water supply is contaminated. If not, then my concern would focus on the adequate cleanup of the site! [Granada Hills]*
84. *When I took a “Physics Class” (years ago, they taught for every positive there is a negative. Ask you scientists to find out what the negative is for every toxic substance, and then eliminate the problem. [Granada Hills]*
85. *I have always known Rocketdyne is there, but I did not know that there might be hazardous substance contamination. Can you please mail me more information on this subject. [Granada Hills]*
86. *I believe this site exceeds the requirements to be cited as a Superfund Cleanup location. [Granada Hills]*

Public comment focusing on cleanup activities continued:

87. *I had a run-in with inspectors at several facilities, when I question them, I have received nothing but non-fictional facts about any information upon my request. I'm tired of addressing these matters on an informal ballot or petition. Please send me better information, more information. I was not aware of this new location at Chatsworth and the SSFL. I cannot return my opinion unless I know everything about the facility, and what was there before this laboratory. [Granada Hills]*
88. *I understand it is extremely unsafe to live in an area that has shown to have hazardous substance contamination. Rocketdyne Santa Susana needs to be carefully checked to make sure the area they contaminated is cleaned up so people in the area can feel it is safe to continue living where they have home and family. Rocketdyne should be punished severely. [Granada Hills]*
89. *Despite all the safety concerns in the engineering development test lab, there was a massive use of Trichloroethane solvent by almost everyone in the test lab. It wasn't looked at as dangerous. When I worked in the structural test area, we cleaned test fixtures and the floor with buckets of Tric. and rags. [Granada Hills]*
90. *I strongly believe the community needs to be informed of the potential hazards that we are, or may be exposed to. As well as a comprehensive fact sheet on mitigation. [Granada Hills]*
91. *I've always wondered if this place needed cleaning up! [Granada Hills]*

Public response from Malibu:

92. *Hazardous substances affect all of us. While cleaning up is highly important, prevention is equally important. [Malibu]*

Public response from Northridge:

93. *The Rocketdyne site needs to be cleaned up. We own a property near the facility and would like to see that they do a good job on this. [Northridge]*
94. *My opinion is that too much is being made of the hazardous substance contamination at the Rocketdyne site. The problem is confined to a local area and is not that big a deal! [Northridge]*
95. *I'm hoping this cleanup will be finished! It truly concerns me. I think there is more behind this problem than appears! [Northridge]*
96. *I have lost track of what is the current situation on the cleanup of the laboratory. [Northridge]*
97. *My only comment is my concern with the integrity of the cleanup activities at SSFL, and also investigating outlying areas of the Laboratory for possible contamination. [Northridge]*
98. *Stop allowing contractors and developers to build on the area surrounding the facility. Continue to cleanup most polluted areas. Create a green zone until the site is mitigated. [Northridge]*
99. *Do not allow the current president to cut back on cleanup funds. [Northridge]*

Public comment focusing on cleanup activities continued:

100. *Care should be taken in test sites that have long ago been dismantled and forgotten. [Northridge]*
101. *The clean up should be at Rocketdyne expense, and full disclosure and monitoring of clean up should be done. [Northridge]*
102. *I worked at SSFL for two years and at one time was handling drums of chemicals. [Northridge]*
103. *The responsible party(s) must be required to cleanup the site as soon as possible. [Northridge]*

Public response from San Fernando:

104. *We thought the problem had been solved long ago. I would need to know more about the present risks as well as any proposed solutions before supporting any action. [San Fernando]*

Public response from Santa Susana:

105. *Is our water supply safe? [Santa Susana]*

Public response from Simi Valley:

106. *I thought the site was already cleaned up? [Simi Valley]*
107. *Ground contamination is probably best treated by stabilizing it to keep it from migrating rather than removal. Removal runs a high risk of spreading contamination to other areas. [Simi Valley]*
108. *I am very concerned about the water table in Simi Valley [Simi Valley]*
109. *I just bought this mobile home, how concerned should I be. We don't even want to drink the water and that becomes very expensive. [Simi Valley]*
110. *I have heard rumors of toxic waste dumping. I am concerned about the water supply and soil. [Simi Valley]*
111. *Clean it up!! Rocketdyne Not fair we have to have it in our lives & back yards. [Simi Valley]*
112. *Any contamination of the ground water aquifers in Simi Valley should be of major interest to all who live here since in many areas the water table is above ground level and near the surface. Not enough has been done to clean up that site! It is a DISGRACE!!! [Simi Valley]*
113. *The site should be required to be cleaned as thoroughly as possible to safeguard the health of future generations. [Simi Valley]*
114. *A friend worked there when it was open – he was a fireman. He told me they put hazardous materials into the ground well. About 2 years ago in 1999, my friend went hiking back there and said they saw yellow strange stuff oozing from the ground. [Simi Valley]*
115. *I'm concerned about groundwater contamination as well as radioactivity! [Simi Valley]*

Public comment focusing on cleanup activities continued:

116. *I live here and get public well water from the area. I would like to know what is going on. Thank you. [Oakhaven Ave., Simi Valley]*
117. *“Ocean Arks International has developed advanced systems of wastewater treatments based on stimulated ecosystems and solar designs able to treat even the most noxious substances and serve the community needs on a wide range of wastes.” Quoted from “Restoring the Earth” by Kenny Ausabel. [Simi Valley]*
118. *We are appalled by the news that the cleanup will not be as thorough as originally recommended. We are planning to move out of the area as soon as we can afford it for our health as well as our three children’s (under 4) sakes. [Simi valley]*
119. *Tell us if it is safe or harmful. Take measures to mitigate harm. [Simi Valley]*
120. *I would like to know if where I live is safe, or if there is any possible contamination here. Also, I’d like to know if the water that my family drinks is safe, meaning, is our tap water safe to drink and cook with? [Rory Lane, Simi Valley]*
121. *I know the cleanup was a forced issue. Probably if harm was to happen it has and is being monitored now. [Simi Valley]*
122. *My words only. This facility has been sending radioactive waste into the atmosphere since it was built. There have been at least 15 near meltdowns or more over the years. These are denied when this facility is called. I used to personally know one man that became very ill after drinking water from a stream below the facility while hiking near Woolsey Canyon. After years of denial, why are you interested now? [Simi Valley]*
123. *When working for Rockwell/Boeing I was an engineering manager for over 20 years and also held an active Professional Engineering License in Nuclear Engineering. As I recall, the “burn pit” was the last area to be cleaned up, and this task of cleanup was taken care of many years ago. I retired ten years ago. [Simi Valley]*
124. *I am concerned about ground, air, and noise pollution. [Simi Valley]*
125. *Be diligent and responsible in your findings and cleanup efforts. Testing should be representative rather than statistical only. Work to complete the efforts, rather than dragging your feet. [Simi Valley]*
126. *I am interested in learning more about the chemicals that are in the air, soil, and groundwater. I would also like to know more about cleanup activities and if the Laboratory is continuing to pollute the area. [Simi valley]*
127. *I am interested in any sort of investigation regarding the area around the site located on your map for environmental reasons. I have several friends and relatives in the area. Have chemicals been found in the area (ground, soil, water, etc). I’m in protest of any and all dumping. [Dalhart Ave., Simi Valley]*
128. *I have the highest regard for Rocketdyne and the services they made to both our space agency and security. However, the failure of the U.S. Government to take ownership and accountability to manage the safe disposal of toxic substances used on the site are inexcusable. The U.S. Government needs to reimburse the public and Rocketdyne for exposure for these known toxins. [Simi Valley]*

Public comment focusing on cleanup activities continued:

129. *I believe that Rocketdyne should be held responsible for poisoning the site and should be made to cleanup the area in its entirety. [Simi Valley]*
130. *Fill the reservoir and make the area accessible to the public at large. Spend the money on access to the area. [Simi Valley]*
131. *We just moved here four years ago. We are concerned for the water contamination that is still a threat. And now our property value too. Health is more important. [Simi Valley]*
132. *I would like to know if the water, air, and soil are contaminated. If so, please provide additional information. [Simi Valley]*
133. *My understanding is this is mainly concerned with radiation. If the radiation levels are below that received in an airplane at 40,000 feet, the project should be abandoned as complete. [Simi Valley]*
134. *I am extremely concerned about the level of cleanup being discussed currently. My family and I reside only miles from this location (SSFL) and nothing but a 100% clean up would be satisfactory to protect my family and future children from unsafe toxic levels in our environment. [Simi Valley]*
135. *The real technical issues get overwhelmed by emotions, and finger pointing. It would also be good to know how groups such as "Bridge the Gap" are funded. [Simi Valley]*
136. *How does the cleanup effect ground water where I live? [Alta Street, Simi Valley]*
137. *What is the area of concern in Simi Valley? Can a map of toxins be posted, as well as the toxins, what toxins? [Simi Valley]*
138. *Additional site – Simi dump, 1952 through 1978, nuclear isotopes dumped in disposal can. [Simi Valley]*
139. *Why is it taking so long to cleanup this site? Why hasn't Rocketdyne already completed cleanup required by U.S. Government? [Simi Valley]*
140. *My brother worked for Rocketdyne before his death. He was aware of problems at the facility early on. He also reported that a building, or a room, at the Canoga Park facility was "Hot" and off limits. It is my impression that he and others were cynical as to Rocketdyne's ability to cleanup the site properly. [Simi Valley]*
141. *Cleanup ends 2006; Rocketdyne pleaded guilty to felony mishandling of hazardous materials; DHS suppressed a cancer study; Rocketdyne claims "all is well!!" [Simi Valley]*
142. *Extremely concerned that toxic substances are controlled to ensure that the health of my wife, me, our children, and grandchildren is not compromised by inadequate controls. [Simi Valley]*
143. *Doesn't seem like anybody knows what's going on up there as far as toxic substances goes. Simi Valley seems to be the last one to know about it. [Simi Valley]*
144. *I would like to find out more about levels of contamination, kinds of contamination, and if there are airborne concerns or water contamination dangers. [Simi Valley]*
145. *I have a water well which could be checked at Cochran & Stearns streets in Simi. [Simi Valley]*

Public comment focusing on cleanup activities continued:

146. *I live just down the mountain from the SSFL. I worry about the safety of our drinking water, so I buy water. [Simi Valley]*
147. *What is the status of the cleanup of the contamination of our groundwater that has occurred since this facility opened, and what has been done to stop the contamination. [Simi Valley]*
148. *If there is a real problem I'd like to know. [Simi Valley]*
149. *I think Rocketdyne and Boeing should expose themselves as having radioactive substances and materials. They have been caught 2x in the past. What's next? [Simi Valley]*
150. *The cleanup of hazardous waste sites is extremely important to the well being of the people, natural environment, and animals of this area. A clean environment enhances all aspects of this area, whether it be healthful, economical, aesthetic, etc. [Simi Valley]*
151. *I'm interested in knowing how and where the contaminated soil is or will be disposed of. I have already lost my husband to cancer. [Simi Valley]*
152. *I think it is appalling that chemicals and other toxic substances are seeping into the ground water where people are drinking the water and living next to it. It is ridiculous that this activity is and was occurring for any amount of time. [Simi Valley]*
153. *Toxic substances should be isolated in a place where no one will be affected. [Simi Valley]*
154. *I would like to be informed of the current level of toxic exposure and risk level based on the amount of time I have lived in Simi Valley and proximity of the SSFL. I moved to central Simi in June 1972, then to North Eastern Simi in 1977. Please respond in a timely manner to my concerns. Thank you. [Simi Valley]*
155. *How wide spread is contamination, nuclear and chemical? What is the natural water drainage from SSFL property? What are health risks for residents of Simi Valley since 1980? [Simi Valley]*
156. *Clean it up! [Simi Valley]*
157. *I live very close to SSFL, my concern is groundwater contamination. I am concerned about potential cover-ups and not being told the whole truth. My life and that of my children could be at risk. [Simi Valley]*

161. *Why is there even a need to investigate the level of interest with regard to the Rocketdyne site?? Of course people care about their health and possible contamination where they live!! DO WHAT IS RIGHT AND CLEAN UP THE SITE!!!! [Simi Valley]*
162. *I understand that there is a great deal of chemicals and radioactive material stored on site. [Simi Valley]*

163. *Am interested to know what extent water has been effected, and for how long. Is it possible to correct? Any reports of illness in the population? What fines, damages, and reparation has Rocketdyne assumed? [Simi valley]*

172. *I would like a map showing the toxic plume (if any) superimposed on a LA City street map. [West Hills]*
173. *I live near it and I'm quite aware of the level of toxins this company dumped and exposed on the people of my area. [Eagle Mtn. St., West Hills]*
174. *With an enormous amount of as yet uncorelated adverse data surrounding this, time will tell just how detrimental this is. I grew up here, now my children are. [West Hills]*
175. *What is truly going on with the cleanup? Unfortunately with the community closing in and around, this site will eventually close? Or move. [West Hills]*

Public comment focusing on cleanup activities continued:

176. *More information on effects of water supply (i.e. the water table system etc). [West Hills]*
177. *More cleanup is needed. The current process is too slow, and poses a health risk to the public. Home owners should be notified of health risks. Homeowners should be notified of health risks from home gardens and fruit trees. [West Hills]*

186. *I would like to know specifically when, and the routes that the trucks will be hauling the contaminated soil will be taking. I have a newborn and am very concerned and will take appropriate measures to avoid those routes. [West Hills]*

45. *I moved here in 1976. At that time I was told that nothing hazardous to my health was happening there. The Senator told me about a reactor meltdown at that site. [West Hills]*

The Real Estate agent put some kind of release on the hood of my car and said, in passing and quite casually, “Oh this is just a formality. There’s really nothing to it but legally I am required to get your disclaimer.” It was too late for me to object at that point. Any sales in area should be required to provide information up front. [Simi Valley]*
9. *Due to possible impact on my home and surrounding area. I am very concerned that this situation be rectified ASAP. [Simi Valley]*
10. *I’m upset that I wasn’t told about this before I bought my home. Now I’m stuck. [Simi Valley]*
11. *I knew nothing of this situation when I purchased my home. [Simi Valley]*
12. *I just became a Realtor, I would like to be kept abreast of what is happening. [Simi Valley]*
13. *I will be a new homeowner at the Oaks development in 2/02. It is located in the Knolls Foothills and very close to the cleanup activities. I would like to know any potential or future hazards my family could be subjected to. [Simi Valley]*

18. *I am a resident in this area and due to the fact that I know of products manufactured and used in the manufacturing process, I am concerned about the toxins within this area. Prior to purchasing our residents, we had an independent agency perform tests on our property and within close proximity to the site. [West Hills]*

19. *If this is a health hazard, all homeowners must be informed and notified and all prospective homebuyers need to be notified as well. We were not aware of this situation when we moved to West Hills. [West Hills]*

20. *We actually lost the sale of our house due to the possible new owners checking with EPA. [West Hills]*

21. *I learned of it after I moved here. I think my landlord legally should have been compelled to tell me about it. I moved here in August 2001. [West Hills]*

22. *We are very interested as an individual and member of a Home Owners Association. I will pass the information on. We have 239 homes in our area. [West Hills]*

4. *I belong to the North Valley Coalition to help us keep abreast of issues re. Sunshine Canyon Landfill. We have been very disappointed with the lack of dedication amongst our City Council regarding our health concerns. Only Hal Bernson has supported the valley viewpoint. [Granada Hills]*
5. *We are much more concerned with the pollution etc from the Sunshine Landfill. [Granada Hills]*
6. *Where I live is ½ a mile from a huge landfill called Sunshine Canyon, I have radon gas in the soil and under my house. Consequently, we are impacted by a lot of toxic substances here. [Granada Hills]*
While the SSFL is not of immediate concern to residents of Granada Hills, the issue of toxic substances control certainly is, particularly as it applies to the Sunshine Canyon Landfill. The landfill is in a seismically active area adjacent to the Jensen Water Purification Facility, a city reservoir, a densely populated community, and an elementary school. There has been serious violations, including alleged dumping of toxic waste that suggest the need for stronger supervision. Please Help. [Granada Hills]
7. *Thank you for the enclosed questionnaire regarding the investigation of hazardous waste at the Santa Susana Field Laboratory. I am concerned about issues that effect our environment and I would like to know what your agency is doing about hazardous waste conditions at the Sunshine Canyon Landfill located in Sylmar, CA. On April 28, the Hazardous Materials team of the Fire Department was called to investigate emissions coming from the drainage system that runs throughout the dump. High levels of Hydrogen Sulfide measured 164 ppm to 185 ppm that is far in excess of toxic levels. Methane emissions measured up to 28%, far in excess of the 5% legal limit. Mr. Larry Israel of the AQMD reported in September 2000 that the monitoring instruments used to measure the levels of Methane at Sunshine were far beyond its capacity to measure. The hazardous waste at The Sunshine Canyon Dump continues to fester, the dump must be closed and the cleanup process begin. [Granada Hills]*
